

**ORDINANCE NO. 6766**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SHERMAN, TEXAS, DECLARING AS ELECTED THE UNOPPOSED CANDIDATES FOR THE OFFICE OF MAYOR AND CITY COUNCIL MEMBER FOR AT-LARGE, PLACE 1 AND AT-LARGE, PLACE 2; FINDING THAT ALL NECESSARY AND REQUIRED LEGAL CONDITIONS HAVE BEEN SATISFIED; PROVIDING THAT THE NOVEMBER 5, 2024 REGULAR MUNICIPAL ELECTION FOR CITY COUNCIL SHALL NOT BE HELD; PROVIDING FOR POSTING OF THIS ORDINANCE ON ELECTION DAY, NOVEMBER 5, 2024; PROVIDING A REPEALER CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING AN EFFECTIVE DATE; FINDING AND DETERMINING THAT THE MEETING AT WHICH THIS ORDINANCE IS PASSED WAS NOTICED AND IS OPEN TO THE PUBLIC AS REQUIRED BY LAW.**

**WHEREAS**, the City Council of the City of Sherman, Texas ("City Council"), adopted Ordinance 6755 on August 5, 2024, ordering that a Regular Municipal Election be held on November 5, 2024, for the purpose of electing a Mayor, and City Council Members for At-Large, Place 1 and At-Large, Place 2, for full terms, as defined in the Charter of the City of Sherman, Texas; and

**WHEREAS**, pursuant to Sections 143.007 and 146.054 of the Texas Election Code, the deadlines for filing applications for a place on the ballot and for the declaration of write-in candidacy for the City's Regular Municipal Election have expired, and

**WHEREAS**, the Sherman City Council, in accordance with Section 2.052 of the Texas Election Code, has received from the City Clerk a "Certification of Unopposed Candidates" (see attached), certifying that Shawn Teamann, Henry Marroquin, and Juston Dobbs are unopposed for election to the positions of Mayor, Council Member, At-Large, Place 1, and Council Member, At-Large, Place 2, respectively, and

**WHEREAS**, the City Council, upon receipt and review of such written certification, hereby finds and determines that the candidates whose names are to appear on the ballot in said Election for Mayor and At-Large City Council Members are unopposed, there are no declared write-in candidates, and no propositions are to appear on the ballot for said Election;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SHERMAN, TEXAS, THAT:**

**SECTION 1. FINDINGS INCORPORATED.**

That the findings set forth above are found to be true and correct and are hereby incorporated into the body of this Ordinance for all purposes as if fully set forth herein.

**SECTION 2. DECLARING CANDIDATES DULY ELECTED.**

That, in accordance with Section 2.053(a) and (c) of the Texas Election Code, the following unopposed candidates are hereby declared duly elected to the respective office shown and shall be issued a Certificate of Election on or after Election Day:

**Shawn Teamann, Mayor**  
**Henry Marroquin, Council Member, At-Large, Place 1**  
**Juston Dobbs, Council Member, At-Large, Place 2**

**SECTION 3. CANCELING REGULAR ELECTION.**

That, in accordance with Section 2.053(b) of the Texas Election Code, the Regular Municipal Election for the City Council heretofore called and ordered for November 5, 2024 shall not be held and is hereby canceled.

**SECTION 4. REQUIRING POSTING OF ORDINANCE.**

That, in accordance with Section 2.053(b) of the Texas Election Code, the City Clerk is hereby directed to cause a copy of this Ordinance to be posted on Election Day, same being November 5, 2024, at all polling places that would have been used in such Election.

**SECTION 5. REPEALER CLAUSE.**

That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

**SECTION 6. SEVERABILITY CLAUSE.**

That the provisions of this ordinance are severable and the invalidity of any word, phrase or part of this ordinance shall not affect the validity or effectiveness of the remainder of the ordinance.

**SECTION 7. FINDING AND DETERMINING.**

That it is hereby officially found and determined that the meeting at which this ordinance is passed is open to the public and that public notice of the time, place, and purpose of said meeting was given as required by law.


