AFFIDAVIT REQUEST FOR DRIVER SAFETY COURSE

I request to take:

I have a valid Texas driver's license, number \_\_\_\_\_

I **DO NOT** hold a commercial driver's license (CDL)

I am not taking, and have not completed an approved driving safety course or motorcycle operator training course within the past 12 months preceding the date of this offense.

I am not charged with speeding 25 or more mph over the posted speed limit and I was traveling less than 95 mph.

I have attached proof of financial responsibility as required by the Texas Motor Vehicle Safety Responsibility Act (Transportation Code Chapter 601).

I understand that:

- Acceptable payment for the court costs and fees, in the amount of one hundred forty six dollars (\$146.00) are cash, credit/debit card, cashier's check or money order
- I have ninety (90) calendar days from today's date to complete an approved Driving Safety Course or Motorcycle Operator Course.
- I am responsible for returning this to the Court written proof showing that I have completed the Course and I hereby promise to present such proof by mail or in person no later than ninety (90) calendar days from today's date.
- I am required to obtain my driving record from the Texas Department of Public Safety and return that driving record to the Court with my proof of completion of the Driving Safety Course or Motorcycle Operator Court.
- Upon failure to comply with the ninety (90) day provision, I will be required to appear in the Court to SHOW CAUSE why I have failed to furnish proof of successful completion of an approved course.
- My case will not be dismissed until the Court receives the following:
  1. Original completion certificate, signed by student for Court: Grayson County JP3.
  2. Certified Driving Record from the Texas Department of Public Safety.
  3. Copy of proof of insurance coverage.
  4. Payment of One hundred forty six (\$146.00) for the court fees & court costs
- When I have completed the above conditions & have returned with proof, thereof, the Court will dismiss. It will be noted on my driving record that I have completed a Driving Safety Course or Motorcycle Operator Course.
- The approved driving school will charge a fee for the Driving Safety Course or Motorcycle Operator Course
- The Court Fee/Costs is non-refundable, whether or not I complete the Driving Safety Course or Motorcycle Operator Course.
